

**Power of attorney for Customs Clearance Activities**

**Customs representative authorization**

This authorization serves to authorize and commission a Customs Representative for the performance of any customs handling required to move Items cross border.

- 1. .... ("Customer"), having a principal place of business at ....., hereby commissions and authorizes G3 Worldwide Mail (Poland) sp. z o.o., ("Customs Representative") with its registered office in Rondo ONZ 1 XXVp., 00-124 Warszawa to make the declarations as prescribed in the customs legislation, and where applicable in other legislation, in the name of and/or for the account of Customer. Customs Representative accepts authorization and commission under the understanding that the assistance by Customs Representative shall be rendered at Customer's sole risk.
- 2. Customer holds registration numbers, applicable for the Service to provide by Customs Representative, which are listed in annex 1.
- 3. This authorization and commission apply to (a) shipment(s) of Items presented by or on behalf of Customer to Customs Representative under the Agreement, which includes (if applicable) an appointed subcontractor as per article 5, for which Customer will provide Customs Representative with all relevant records and information, both in conformity with all laws and regulations, including but not limited to customs legislation.
- 4. This authorization and commission include all acts and communications, including written objections, up to and including but not limited to the completion of the verification of the declaration and those connected to the amount of customs debt and the presence of Customs Representative in case of audits and/or spot checks by the customs authority.
- 5. In case of any acts, communication or any other post-declaration action is required, Customer authorizes and commissions Customs Representative for (including but not limited to) the following:
  - a. To submit requests for repayment/remission as well as to submit written objections relating to data incorrectly stated in the declaration compared to the information supplied when the request for assistance was placed;
  - b. To proceed, at request of Customer, to submit request for repayment/remission as well as to submit written objections, because incorrect information was supplied when the request for assistance was placed;
  - c. Separate, case-by-case agreements are required to make other requests, written objections and lodging appeals.
- 6. Customer authorizes Customs Representative to appoint a subcontractor to act as Customs Representative for Customer. The subcontractors appointed by Customs Representative are listed in annex 1 to this authorization.
- 7. This authorization applies for a determinate period of time of three years, effective as of the date this authorization is signed. The Customs Clearance Activities under the Agreement, for which this authorization is required, can only commence upon receipt of a duly signed authorization by Customs representative.
